SUBJECT: **Grants for Student Needs (GSN) 2018-19, Supports and Updates**

This memo will provide updates for the 2018-19 GSN, including:

- GSN Funding Regulations
- GSN Products Release
- Benefits Trusts
- Local Priorities Fund
- Literacy and Numeracy Outside the Day School
- EFIS Estimates

1. GSN FUNDING REGULATIONS

The GSN funding regulations for 2018-19 have been made by the Lieutenant Governor in Council. These regulations implement the funding investments, structural reforms, and other changes described in the memorandum 2018: B06 – Grants for Student Needs (GSN) for 2018-19.

Through the GSN regulations, the Government is allocating a projected total of over \$24.53 billion for elementary and secondary education in the 2018–19 school year.

The new funding regulations are:

1. Grants for Student Needs – Legislative Grants for the 2018–19 School Board Fiscal Year;
2. Calculation of Fees for Pupils for the 2018–19 School Board Fiscal Year; and
3. Calculation of Average Daily Enrolment for the 2018–19 School Board Fiscal Year.

All of the above regulations may be accessed through the [Ministry's public website](#).

The implementation of the province's GSN funding commitments has also required technical amendments to the 2015–16, 2016-17 and 2017-18 GSN and related regulations.

Honoraria for Board Members Regulation

O. Reg. 357/06 – Honoraria for Board Members under the *Education Act* has been amended to:

- Increase the base amount limit allocation for district school board (DSB) trustees; and
- Establish honoraria limits for members of hospital boards established under section 68 of the *Education Act* as well as for members of the Centre Jules-Léger Consortium (CJLC).

The above changes will be effective for the term of office beginning in December 2018.

In addition to the changes to the regulation described above, the Ministry of Education has committed to the establishment of a working group in fall 2018 with the school board associations and student trustee associations to review the honoraria for trustees and student trustees in district school boards and trustees in isolate school boards.

Fees for Central Bargaining Regulation

Under the *School Boards Collective Bargaining Act, 2014*, trustees' associations are the statutorily designated employer bargaining agents at all central collective bargaining tables and, as such, require funding to fulfill this key role.

The Fees for Central Bargaining regulation is an annual Minister-made regulation. It provides the framework for the support of labour relations activities for the trustees' associations in the 2018-19 school board fiscal year by authorizing the flow of funds from school boards to trustees' associations through the annual GSN process.

No material changes have been made for the 2018-19 school year.

The regulation retains the following key elements:

- The fee to be paid by an individual school board to their respective central employer bargaining agency;
- The obligation for fees to be paid;
- An annual deadline of October 15th for payment of fees; and
- The forfeiture of ratification voting rights in the event of non-payment by November 15th.

Total funding for all associations is nearly \$4.6 million, the same amount as for the 2015-16, 2016-17 and 2017-18 school years. As shown in the following table, the amount of total funding provided to each designated bargaining agency differs. This reflects the associations' varying levels of participation in central bargaining with teachers' federations and education workers' unions.

The regulation continues to be reviewed annually as part of the GSN process.

3. BENEFITS TRUSTS

Additional funding to support benefits transformation is being provided through the GSN. Individual letters have been recently sent to school boards to provide details on the funding calculation to support the costs related to the benefits trusts for 2018-19.

4. LOCAL PRIORITY FUNDS

The GSN memo (2018:B06) provided the total amount for the local priorities fund in 2018-19.

Appendix 1 shows the amount for each school board broken out by central employee bargaining group. For each of the following groups, please refer to the priorities and uses outlined in their central agreement:

- Elementary Teachers' Federation of Ontario (ETFO)
- Elementary Teachers' Federation of Ontario - Education Workers (ETFO-EW)
- Ontario Secondary Schools Teachers' Federation (OSSTF)
- Ontario Secondary Schools Teachers' Federation – Education Workers (OSSTF-EW)
- Canadian Union of Public Employees (CUPE)
- Education Workers' Alliance of Ontario (EWAO)
- Ontario Council of Educational Workers (OCEW)

For L'Association des enseignantes et des enseignants franco-ontariens (AEFO) the funding is being made available for local priority investments designed to enhance student achievement and well-being in the classroom via additional AEFO teacher positions. Local consultations are expected to take place with AEFO representatives. For further information, please consult your trustee association.

In the case of Ontario English Catholic Teachers' Association (OECTA), this funding is being made available for the continued support of the identified full-time equivalency (FTE) of elementary and secondary teachers as specified in the OECTA extension agreement (OECTA Investments 2017-2018) in accordance with the process also identified in the extension agreement.

The *Others* column in Appendix 1 is primarily a provision for principals and vice-principals as well as any other staff that are represented by other unions or are non-unionized. Boards have discretion over the use of these funds but are subject to the agreement with principals and vice-principals and any agreements boards may have with other union groups on the use of these funds.

The increase in total funding through the Local Priorities Fund in 2018-19, from 2017-18, primarily reflects the increase for the Adult Day School Teachers investment specified in the OSSTF agreement for 2018-19 and an adjustment for other amounts to provide a 1.5% increase to support the costs of the negotiated salary increases for staff funded through the Local Priorities Fund.

Consistent with the approach followed in 2017-18, additional reporting on the spending of Local Priorities Fund will be required in the 2018-19 Financial Statements. The ministry will provide a preview of the reporting requirements through a separate Excel template which can be downloaded through the “Facilitating Documents” folder in EFIS. Various expense categories are pre-loaded based on the central agreements as well as additional blank lines to put in the details of other spending. This template is not part of the 2018-19 Estimates submission.

5. LITERACY AND NUMERACY OUTSIDE THE SCHOOL DAY

In the GSN memo (2018:B06), expanded eligibility was announced for funding in remedial literacy and/or math courses/classes starting in 2018-19. For clarity, all day school and continuing education students, regardless of their age, are now eligible for funding in remedial literacy and/or math courses/classes.

Continuing Education students, as well as adult day school and fully high-credit pupils enrolled in day school, will now be funded for these courses/classes through the Continuing Education and Other Programs Grant (i.e., at the ADE rate for Adult Day and High-Credit Secondary Day School, Summer School students, and Continuing Education students).

6. EFIS ESTIMATES

The 2018-19 Estimates, related guides and instructions are now available through the “Estimates” link on the “Reporting to the Ministry” section of the [Financial Analysis and Accountability Branch \(FAAB\) website](#).

Please submit your 2018-19 Estimates through [EFIS 2.0](#). The forms implement the GSN changes announced in memorandum 2018:B06.

Ministry approval for in-year deficit

Please be reminded that in accordance with section 231 of the Education Act, school boards must seek the Minister's approval for any in-year deficit that exceeds the lesser of:

- the accumulated surplus available for compliance from the preceding year or
- one percent of the board's operating allocation.

Boards should seek ministry approval prior to the final board's approval of the budget. The approval from the ministry must be obtained at any point during the fiscal year when it becomes known to the board that its projected in-year deficit will exceed the threshold set out in section 231 of the Education Act. A new approval from the ministry is required if the projected in-year deficit has increased from the previous approved amount.

The details on the process for requesting ministry approval are described in the 2018-19 Estimates instructions document.

Please submit your 2018-19 Estimates electronically by **June 29, 2018**. Also submit an electronic copy of the following documents:

- Signed certificate of the Director of Education
- Compliance Report
- Schedules 9, 10 and 10ADJ
- Section 1A summary (all pages);

The documents should be saved in pdf file format and submitted as an attachment to the following email: estimates.met@ontario.ca. The file name used should follow the [naming convention](#) specified on the FAAB website and boards are asked to include the following text in the subject line of the email "2018-19 Estimates Supporting Documentation – DSB ##".

Late Submissions

The policy on late filing will be applicable to the 2018-19 Estimates. Where a board submits its Estimates after June 29, 2018, its regular cash flow will be reduced by 50%. Upon submission of the Estimates, the ministry will revert back to the normal monthly payment process and will include in the monthly payment the total amount withheld up to that point.
